#### AN ORDINANCE

AMENDING FILE OF THE COUNCIL NO. 110 OF 2005 AN ORDINANCE ENTITLED "AMENDING FILE OF THE COUNCIL NO. 45 OF 1996 REGARDING THE COMPREHENSIVE PROGRAM FOR HISTORIC PRESERVATION IN THE CITY OF SCRANTON BY UPDATING THE LIST OF HISTORIC PROPERTIES" TO FURTHER UPDATE AND ADD THE CLELAND HOUSE AT 520 MADISON AVENUE TO THE HISTORIC PROPERTIES LIST.

WHEREAS, on April 14, 2014 the Historic Architectural Review Board ("HARB") met and voted to include the Cleland House at 520 Madison Avenue to the Historic properties list. A copy of the minutes of the meeting are attached hereto as Exhibit "A" and incorporated herein by reference thereto; and

WHEREAS, by letter dated March 16, 2015 the Historic Architecture Review Board requested the Law Department amend Ordinance 110 of 2005 to include the Cleland House at 520 Madison Avenue as a recognized historic cultural and artistic resource within the City.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SCRANTON that File of the Council No. 110 of 2005 is hereby Amended to include The Cleland House at 520 Madison Avenue to list of historic properties

SECTION 1. In all other respects, File of the Council No. 45 of 1996 shall remain in full force and effect.

SECTION 2. If any section, clause, provision or portion of this Ordinance shall be held invalid or unconstitutional by any Court of competent jurisdiction such decision shall not affect any other section, clause, provision or portion of this Ordinance so long as it remains legally enforceable minus the invalid portion. The City reserves the right to amend this Ordinance or any portion thereof from time to time as it shall deem advisable in the best interest of the promotion of the purposes and intent of this Ordinance, and the effective administration thereof.

SECTION 3. This Ordinance shall become effective immediately upon approval.

To Whom It May Concern,

On April 14, 2014 the Historic Architectural Review Board (HARB) met to determine whether the Cleland House located at 520 Madison Avenue should be included on the City's list of historic properties. The HARB voted yes and recommended 520 Madison Avenue be added to the historic property list. On April 9, 2015, City Council approved HARB's recommendation and added the Cleland House located at 520 Madison Avenue to be included on the list of historic properties. This ordinance is FOC # 93 of 2015.

As per the PA Uniform Construction Code section 403.24 titled "Historic buildings, structures and sites,"

A "building code official may exclude an entire historic building or structure or part of the building or structure from compliance with the Uniform Construction Code if it meets all of the requirements in section 403.24."

Based on the above, I find that the Cleland House located at 520 Madison Avenue meets all of the requirements of the UCC section, 403.24. Therefore, the automatic sprinkler system requirement (IBC 2009 Section: 310.0 Residential Group R-1) is hereby waived. Please know a Building Code Official cannot waive the Uniform Construction Code's accessibility requirements.

The Cleland House located at 520 Madison Avenue (Basement, 1st & 2nd Floors) is not to be used, operated or occupied in any way until of Certificate of Occupancy has been issued.
