## **Photography Release**

I hereby authorize the City of Scranton, its agents, and its employees to take photographs, video recordings, and/or audio recordings of the Camper. I understand that these images and recordings may be used for promotional materials, on website and social media platforms, official City of Scranton communications, and any other lawful purposes.

### **CAMP RULES**

## **Pickup and Drop off**

- All campers must be, and may only be, released to a parent/guardian designated on this form or by an emergency contact designated on this form.
- Drop off is at 8:15am at the earliest and pick up is 3:00pm.
- Parent/Guardian must walk their camper into the building at drop off and walk their child out of the building at pick up time.
- Campers cannot be released to anyone under the age of 16.

## **Camp Items**

- Campers must provide their own appropriate swimsuit, towel (shower shoes recommended). Campers should dress appropriately for the warm weather.
- Campers should provide their own sunscreen as many activities will be outdoors.
- Campers should bring their own water bottle labeled with their name. A bottle filling station/water fountain is on site for access to water.
- Campers should leave valuables at home including cell phones. If a camper wishes to bring their cell phone to camp, it is <u>their</u> responsibility to keep it secured.
- Phone use in the locker rooms or pool area is prohibited.

#### **Behavior**

The camp reserves the right to suspend or remove a camper for inappropriate behavior. Camper will follow the rules below:

- I will keep my hands and feet to myself.
- I will not fight or play fight with my friends.
- I will not use vulgar language including swearing, name calling or shouting
- I will be responsible to clean up my space.
- I will be respectful and listen to Camp Counselors while they give me directions
- I will report inappropriate behavior to our Camp Counselors
- I will use the playground equipment appropriately.
- I will not leave the room without asking Camp Counselors first
- I will not carry or conceal any weapons or devices that may be used as weapons.
- I will not demonstrate any sexual activity or sexual contact with another person.
- I will not demonstrate behavior which intends to, or results in, the theft or destruction of property.

#### **How Staff will Address Behavior**

- Staff will give a verbal warning and/or redirect the camper to more appropriate behavior.
- On the first offense: The camper will be reminded of the behavior guidelines and camper be allowed to continue to participate in camp activities.
  If the behavior persists, a parent will be notified of the problem. The staff will document the situation. The written documentation will include what the behavior problem is, what provoked the problem and the corrective action taken. Parent will be called to pick up camper that day.
- On the second offense: The camper will be reminded of the behavior guidelines and rules and camper be allowed to continue to participate in camp activities.
  If the behavior persists, a parent will be notified of the problem. The staff will document the situation. The written documentation will include what the behavior problem is, what provoked the problem and the corrective action taken. Parent will be called to pick up camper that day.
- If the camper continues to disregard the rules as stated above for a 3<sup>rd</sup> day, camper's parent/guardian will be called to pick them up. Camper will not be allowed back to camp and camp slot will be given to the next child on the waiting list.
- If a camper's behavior at any time threatens the immediate safety of themselves, other children, or staff, the parent may be notified and expected to pick up the camper immediately. Camper will not be allowed to return.
