NOTICE IS HEREBY GIVEN THAT SCRANTON CITY COUNCIL WILL HOLD A SPECIAL MEETING ON MONDAY, JANUARY 30, 2012 AT 6:30 P.M. IN ORDER TO ADOPT THE FOLLOWING ORDINANCES AND RESOLUTION:

EMERGENCY CERTIFICATE

AUTHORIZING THE ISSUANCE AND SALE A TAX AND REVENUE ANTICIPATION NOTE OF THE CITY OF SCRANTON KNOWN AS TAN SERIES 2012 IN AN AMOUNT NOT TO EXCEED TWELVE AND ONE HALF MILLION (\$12,500,000.00) DOLLARS AWARDED TO THE FIDELITY DEPOSIT AND DISCOUNT BANK; DETERMINING THE FORM AND TERM OF SAID NOTE; AWARDED SAID NOTE; AUTHORIZING AND DIRECTING THE FILING OF CERTAIN DOCUMENTS; AND DIRECTING THE PROPER OFFICIALS OF THE CITY OF SCRANTON TO TAKE ANY AND ALL OTHER ACTIONS AS MAY BE REQUIRED IN CONNECTION WITH THE ISSUANCE OF SAID NOTE.
