All of the vehicles can be inspected now through the opening of the quotes in the rear parking lot of the Scranton Police Department at 100 South Washington Avenue Scranton, Pa. 18503 Monday- Friday between 7:30am & 5:00 pm or respectively at the front parking lot of the DPW Complex 101 W. Poplar Street Scranton, Pa. 18509. The vehicles that are included in this sale are clearly marked with an “X” on the windshield. None of the police accessories (emergency lights, sirens, police radio’s, etc.), where applicable, shall be included in the sale and said items will be removed by the city of Scranton prior to the removal of the vehicles from the lot by the successful bidder/buyer. **All sealed quotes received will be opened in the City Controller’s Office on Monday October 7, 2019 at 11:00 am.
